COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Bruce F. Hopkins

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of -----Twenty Four Thousand Six Hundred and No/100-----

DOLLARS (\$ 24,600.00 ) with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums that may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, and for any other purpose, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the Mortgagor is hereby acknowledged, has granted, bargained, sold and released, and by these presents, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, on the western side of Zelma Drive (also known as Engel Drive), being known and designated as Lot No. 31 on plat of Oakland Terrace Subdivision, prepared by C. C. Jones & Associates, recorded in the Office of the RMC for Greenville County in Plat Book "38", at Page 196, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Zelma Drive (also known as Engel Drive), at the joint front corner of Lots Nos. 31 and 32, and running with the western side of Zelma Drive S. 7-32 E. 151.6 feet to an iron pin; thence N. 76-30 W. 307 feet to an iron pin; thence N. 21-00 E. 35.8 feet to an iron pin at the joint rear corner of Lots Nos. 31 and 32; thence running with the common line of Lots Nos. 31 and 32 N. 82-28 E. 265.5 feet to the point of beginning.
