To All Whom These Presents May Concern: I, Louise C. Few, - - -

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of


NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greer, on the south side of West Arlington Avenue, bounded by lands of M. E. Cunningham Estate, Ruth C. Paget, William Flack and Mrs. A. F. Craft, having the following courses and distances:

BEGINNING on an iron pin on the south side of West Arlington Avenue, joint corner with M. E. Cunningham Estate, and runs thence S. 27-30 W. 90 feet to an iron pin; thence S. 70-00 W. 41 feet to an iron pin; thence S. 27-30 W. 60 feet to an iron pin; thence S. 70-00 W. 24 feet to an iron pin, corner with Ruth C. Paget; thence with the line of the Paget lot, S. 24-43 E. 148 feet and 7 inches to an iron pin on the south side of Arlington Avenue; thence therewith N. 70-00 E. 75 feet to the beginning corner.
