TO ALL WHOM THESE PRESENTS MAY CONCERN: MILLS MILL LIMITED PARTNERSHIP, a South Carolina Limited Partnership, now by change of name MILLS CENTRE LIMITED PARTNERSHIP (hereinafter referred to as Mortgagor)
SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST NATIONAL BANK OF SOUTH CAROLINA (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note(s) of even date herewith, the terms of which are incorporated herein by reference, in the sum of THREE HUNDRED THOUSAND AND NO/100 DOLLARS (\$ 300,000.00), with interest thereon as provided in said promissory note(s), said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being at the intersection of Church Street and Guess Street in the County of Greenville, State of South Carolina, being more particularly described in Exhibit "A" attached hereto and made a part hereof.
