THIS MORTGAGE is made this 18th day of April 1983, between the Mortgagor, U.S. Retirement Corporation (herein "Borrower"), and the Mortgagee, American Service Corporation of S.C. (herein "Lender"), a corporation organized and existing under the laws of South Carolina, whose address is 101 East Washington Street, Greenville, South Carolina.

WHEREAS, Borrower is indebted to Lender in the principal sum of Nine Hundred Thousand and 00/100 (\$900,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated April 18, 1983 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on April 18, 1984.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this division may be released from the lien hereof upon payment by Mortgagor to Mortgagee of a principal reduction payment equal to the proceeds of this loan actually advanced to Mortgagor and utilized by Mortgagor for construction of improvements on the lot to be released. Mortgagee shall not be required to sign and deliver such release unless and until mortgagor shall also have complied with all obligations necessary to release such lot from the lien of the first Mortgage on the property given by Mortgagor to Mortgagee on April 18, 1983, more fully described below.

This Mortgage is subject and subordinate to the lien of that certain Mortgage given by U.S. Retirement Corporation to American Service Corporation of S.C., dated April 18, 1983, and recorded prior to the recording of this Mortgage.
