THIS MORTGAGE is made this 30 day of SEPTEMBER 1981, between the Mortgagor, DONNA H. BRYANT (herein "Borrower"), and the Mortgagee, FIRST NATIONAL BANK OF SOUTH CAROLINA, a corporation organized and existing under the laws of SOUTH CAROLINA, whose address is PO. BOX 225 COLUMBIA, S. C. 29202 (herein "Lender").

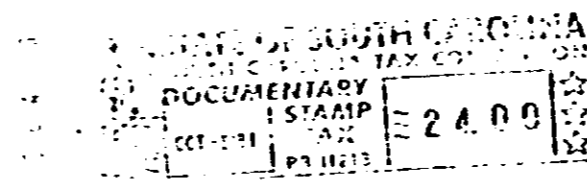
