**SOLICITOR ANNOUNCES WINNERS IN "SAY

The winning students, their parents, art teachers and principals as well as the contest judges were invited to the courtroom presentation.

"I am pleased to continue the drug awareness calendar for the nineteenth year," said Solicitor Wilkins. "It is a positive way to use seized assets of illegal drug dealers to both educate our children about the dangers of drug use and to recognize those who use their talents in a productive way."
