#### 2013 BILLY WILKINS AWARD FOR EXCELLENCE IN LAW ENFORCEMENT

Lieutenant James Beaver of the Greenville County Sheriff's Office and Master Deputy Leslie Daniel of the Pickens County Sheriff's Office were presented the 2013 Billy Wilkins Award for Excellence in Law Enforcement by Retired U.S. Fourth Circuit Court of Appeals Judge William W. Wilkins, Jr. today in ceremonies held in Greenville and Pickens County.

The presentation of this award began in 1984 in honor of former Thirteenth Circuit Solicitor Billy Wilkins, and is presented to individual law enforcement officers who have exhibited outstanding attributes in performance of his or her duties both in the field and in the courtroom.

#### Greenville Sheriff's Office Lieutenant James Beaver

James Beaver was born and raised in Miami, Florida. While a student at the University of Central Florida, his part-time work with a security business led to an interest in law enforcement. In November 1989, James was hired as a deputy with the Greenville County Sheriff's Office as a Uniformed Patrol Deputy. Because of his attention to detail and ability to bring stressful situations to a peaceful conclusion, he was promoted to Master Deputy in January 1994. While serving as a Master Deputy, James expressed an interest in, and was assigned to, the SWAT team. In January 2001, he was promoted to Lieutenant. In September 2004, he was assigned to the Criminal Investigations Division (CID). Shortly after joining CID, James served as the lead investigator on the case involving the murder of well known Greenville businessman Jim Cochman. Under his leadership, two individuals were arrested and convicted of the murder. In 2004 Lieutenant Beaver was promoted to SWAT Commander. As leader of the team, he was responsible for developing new tactics, training techniques, and acquiring updated equipment for the Sheriff's Office.

As is evident throughout his twenty-three years of dedicated service, Lieutenant Beaver is a valuable asset to the Greenville County Sheriff's Office.


Lieutenant Beaver is member of Shannon Forest Presbyterian Church. He and his wife, Andrea, have three children.
