Greenville Men Sentenced on Murder, Armed Robbery, Burglary – First Degree, Possession of Weapon During Violent Crime, Criminal Conspiracy, and Petit Larceny

Thirteenth Circuit Solicitor Walt Wilkins states that defendants, RAYMOND MARTINEZ, JR, age 31, and ROBERT LEE BELCHER III, age 29, were convicted on July 20, 2023 by a Greenville County jury of Murder, Armed Robbery, Burglary – First Degree, Possession of Weapon During Violent Crime, Criminal Conspiracy, and Petit Larceny, and sentenced to 45 years in the South Carolina Department of Corrections by the Honorable Perry H. Gravely.

Evidence presented at the trial by Assistant Solicitor Jay Gresham and another lead Assistant Solicitor established that on the evening of December 31, 2017, RAYMOND MARTINEZ, JR and ROBERT LEE BELCHER III, along with two other co-defendants, who pled guilty, conspired and robbed the victim, Jermaine Bruster, at his residence at the Razor Court Apartments in Greenville County. During the robbery of the victim, MARTINEZ and BELCHER shot and killed the victim and stole a wrist watch and approximately \$81 in loose change from the residence. A thorough law enforcement investigation of the incident conducted by investigator, Lieutenant Chad Maltby of the Greenville County Sheriff's Office uncovered the above facts that connected the defendants to these crimes.
