The Greenville County Council (the "County Council"), the governing body of Greenville County, South Carolina (the "County"), has determined that it may be in the interest of The Greater Greenville Sanitation District, South Carolina (the "District") to raise moneys through the issuance of general obligation bonds of the District in one or more series, in the aggregate principal amount of not exceeding \$34,000,000 for the purpose of defraying the costs of (i) the design, acquisition, construction, equipping and furnishing of a new administration and operations center for the District and such improvements as may be necessary, incidental or related to thereto, including, without limitation, a maintenance facility, fueling stations, a waste transfer station, truck wash facilities and equipment storage (collectively, the "Improvements"), (ii) the payment of a portion of the interest on such general obligation bonds as permitted under the Enabling Act, and (iii) the payment of costs of issuance of such general obligation bonds. The District proposes the issuance of such general obligation bonds for such purposes and the County has ordered a public hearing to be held upon the question of the issuance of such bonds in accordance with the provisions of Title 6, Chapter 11, Article 5, Code of Laws of South Carolina 1976, as amended (the "Enabling Act").

Accordingly, notice is hereby given that a public hearing will be held in the Greenville County Council Chambers, 301 University Ridge, Greenville, South Carolina 29601, beginning at 6:00 p.m. (or as soon thereafter as other hearings are concluded) on November 19, 2024, on the question of the issuance of general obligation bonds of the District, in one or more series, in the aggregate principal amount of not exceeding \$34,000,000, the proceeds of which will be used to defray the aforementioned Improvements, to pay a portion of the interest on such general obligation bonds as permitted by the Enabling Act, and to pay the costs of issuance of such general obligation bonds. The aforesaid public hearing shall be conducted publicly and both proponents and opponents of the proposed action shall be given full opportunity to be heard in person or by counsel.
