the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JAMES C. WELCH, JR., his heirs and assigns, forever:

All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 54 of a subdivision known as Section "A" of Englewood Estates, as shown by a Plat thereof, dated October 1951, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book "Y", at Page 140, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Beaumont Drive at rear corner of Lot No. 54 and front corner of Lot No. 53 and running thence along the line of said Lot No. 53, N. 87-30 W. 100 feet to iron pin at back corner of Lot No. 55; thence along the line of said Lot No. 55, S. 2-30 W. 255.1 feet to an iron pin on Evelyn Drive; thence running with the said Evelyn Drive, S. 53-35 E., 95.5 feet to iron pin at curve; thence in a curve, S. 64-25 W. 23.5 feet to iron pin on Beaumont Drive; thence running with the said Beaumont Drive, N. 2-30 E. 297.2 feet to iron pin at point of beginning.

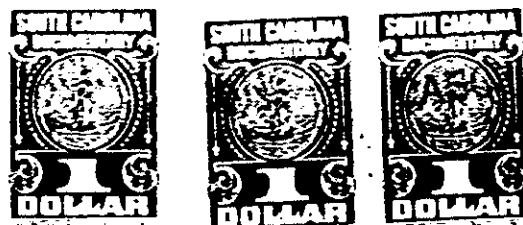
