interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue
thereon and foreclose this mortgage, said note further providing for an attorney's fee of Ten Per Cent

besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); and in and by the said note, reference being
thereunto had, as will more fully appear.

His heirs and assigns: All that certain piece
parcel or lot of land, situate, lying and being
in the State of South Carolina County aforesaid, and being
located in Block Two (2) of the City of Greenville,
and on the west side of Vannoy Street, and having
the following: width and bounds to-wit: Beginning
at an iron pin on the west side of Vannoy Street
three Hundred and ninety-five (395) feet from
the intersection from the south west corner
of Stone Avenue and running thence; N. 71-50
W. One hundred and ninety-two feet and seven
inches (192.7) to a stake; thence S. 20-19 W. fifty-
five (55) feet to a stake; thence S. 71-50 E. one
Hundred & ninety-two feet and seven inches
(192.7) to a stake on Vannoy Street, thence N.
19-20 E. fifty-five (55) feet with Vannoy Street
