computed and paid in advance

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue
thereon and foreclose this mortgage, said note further providing for an attorney's fee of

ten (10%) percent.

besides all costs and expenses of collection, to be added to
the amount due on said note, to be collected as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being

bargain, sell and release unto the said J.W. Norwood, his heirs and assigns forever: All that piece,

parcel or lot of land in Greenville Township, County and State aforesaid, situate
about one-half mile East of the City limits of the City of Greenville, on the
Spartanburg Road, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Spartanburg Road, corner of W. Ross Harris
property; thence along line of said Property N. 24-45 W. 323 feet to an iron pipe on
rear line; thence along rear line S. 81-38 W. 60 feet to an iron pipe, corner of
H.K. Townes property; thence along said line S. 21-45 E. 336.5 feet to an iron pipe on
the north side of Spartanburg Road; thence along the North side of said road N. 69-02
E. 75 feet to the point of beginning, and being a part of the John Thompson tract of
land, containing 13 acres, more or less, conveyed to me by H.K. Townes by deed dated
