thereon and foreclose this mortgage, said note to bear interest for an attorney's fee of 10%

besides all costs and expenses of collection, to be added to  
the amount due on said note to be collectible as a part hereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,  
be collected by an attorney, legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being

My heirs and assigns, all that certain lot of land situate in Ward 2 of the City of Greenville, State and County aforesaid. Beginning at the corner of Maully Street and an alley and running thence with said alley n. 74 1/2 c. One hundred and seventy-eight (178) feet, thence n. 22 1/2 w. fifty-four (54) feet, thence s. 73 w. one hundred and seventy-eight (178) feet to Maully Street, thence with Maully Street s. 15 c. fifty-four (54) feet to the beginning corner. The said lot comprising the two lots of land conveyed by J. A. McCullough to Dizzie Farrow by deed bearing date of Sept. 9th 1908, and recorded in Office of R. M.
