- 2. **Site/Civil Plans** including utility locations, access road dimensions, surface description, fire department access and hydrant locations, and a detail of the parking pads.
- 3. **Plumbing Plans** underground, isometric drawing from each unit, quick disconnect to receptor, either Septic or Sewer. A copy of the sewer or septic permit will be required.
- 4. **Electrical Plans** panel diagram, single line drawing from the unit pad, disconnect and receptacles to the service source including conductor and disconnect, burial depth of conductors to service.
- 5. **Structures** located on-site shall be permitted like any other structure.

6. **Land Development, Subdivisions, and Zoning Department** shall be provided plans for review. A copy of these approved documents shall be included in this set.

- Unlabeled units are not permitted on site. RVs are designed and regulated as seasonal use only. Occupancy shall be limited per the manufacturer's label for seasonal use only.
- 4 All units shall be installed per the manufacturer's set-up instructions and label and each unit's set-up instructions shall be made available to Greenville County upon request.
- Any lease or paperwork indicating the RV Park's regulations shall be in compliance with the information shown on this document and shall remain available to Greenville County upon request.
